
Business Overview:

- Vail Resorts, Inc., through its subsidiaries, operates mountain resorts and regional ski areas in the United States. It has three segments: Mountain, Lodging, and Real Estate.
- Mountain segment operates 41 destination mountain resorts and regional ski areas. This segment generates revenue through lift tickets, pass products, ski and snowboard lessons, equipment rentals, retail merchandise sales, dining venues, private club operations, and various recreational activities throughout the year.
- Lodging segment includes owned and managed properties, such as luxury hotels under the RockResorts brand, and managed condominium units around its mountain resorts.
- Real Estate Segment focuses on selling land parcels to developers and plans future projects, securing zoning and permits.




